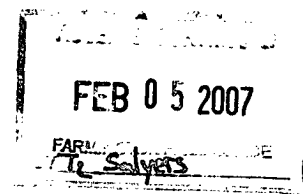

Wash and ream pilot hole w/ 13 1/2" bit to 260'. Clean hole. RIH w/ 6 jnts 9 5/8" 32.3#, H-40 ST&C csg and set @ 245'. RU to cement. Preflush w/ 20 bbl wtr w/dye & 5 bbl scavenger cmt. Pump 262 sx (338 cu ft - 60 bbl) Class III cement w/ 3% CaCL₂, 0.25 pps cellophane flakes. Displaced w/ 17.5 bbl wtr. Circulated 16 bbl cement @ surface. WOC. Will report PT on next sundry.

Surface hole drilled w/ 13 1/2" bit due to using H&P rig.
