01/22/07 Spud 8 3/4" surface hole, drilled to 145'. Ran 3 jts (136.55') of 7", 20#, J-55, ST&C new casing and set at 142'KB. Cemented with 80 sx (94 cu. ft.) of Type 5 with 3% CaCl₂ and 1/4#/sk celloflake. Circulated 5 bbls of cement to surface.

01/23/07 Nipped up the bradenhead and BOP and pressure tested to 1000psi.

01/25/07 Ran 47 jts (1939..51') of 4-1/2" (6-1/4" surface hole), 10.50#, J-55, ST&C production casing and set at 1945'KB. Insert float is at 1921'KB and the top of marker joint is at 1478'KB. Cemented with 150 sx (309 cu.ft.) of Type 5. with 2 % sodium metasilicate, and 1/4#/sk celloflake, followed by 75 sx (89 cu. ft.) of Type 5, with 1/4#/sk celloflake. Bumped plug to 1500psi. Circulated 4 bbls of good cement to the surface. Released rig 01/25/07.
