1st stage: 65sx (20bbl) scavenger of SJ Poz, 4% gel, 0.2% Halad9, 0.15#sx FE-2, lead cmt of 150sx (54bbl) 65/35 CIs B/Poz w/2% CaCl2, 1/4# cellophane, 6% gel, 5#sx Gilsonite @ 12.4 ppg w/10.6 gpsx wtr to yield 2.02 cuft/sx. Tail cmt of 120sx (25bbl) CIs B w/2% CaCl2, 1/4# cellophane mixed @ 15.6ppg w/5.2 g/sx wtr yielding 1.18 cuft/sx. Stage tool @ 3725'.

2nd stage: 300sx (108bbl) 65/35 Class B/Poz w/2% CaCl2, 1/4# cellophane, 6% gel, 5#sx Gilsonite @ 12.4ppg w/10.6 gpsx water to yield 2.02 cuft/sx. Bump plug to 780psi over hydrostatic. Increase pr to 1,980psi to shift stage tool. OK

Circulate cement throughout w/full returns. Cement top @ 3000' by CBL. Perf @ 2900'. Sqz & circ cmt to 160' by CBL.
