1st Stage- 25 sks 10# scavenger, with .25 lbs/sk celloflake, and 5# sk phenoseal. Cemented with 220 sks 13.5# 50:50 Class G Poz , 2.5 lbs/sk phenoseal, .25 lb/sk cello flake, 2% bentonite gel, 4% gilsonite, 1# sk CemNet, yield 1.28. 2nd Stage-Cemented with 550 sks 12.8# 65/35 Class G Poz, with .25# sk celloflake, 5#/sk CemNet, 2.5#/sk phenoseal, 3% gilsonite, 3% bentonite gel, yield 1.75 Circulated 23 bbls cement to surface. WOC cement 12 hours.
