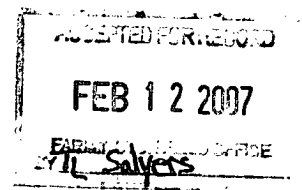

Drilled 8-3/4" hole to 1820' & set 7", 20#, J-55 intermediate csg 12/21/06. Cmt w/85 sx Prem Lite cmt w/2% CaCl2, 1/2 pps Celloflakes, 2% FL-52 & 2% Phenoseal (12.5 ppg & 2.01 cuft/sx) followed by 150 sx Type III cmt w/1/4 pps Celloflakes, 2% FL-52 & 2% Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 2 bbls cmt to surf. PT intermediate csg to 1000 psig f/10 min. Tstd OK.
