Drilled out sq & pressure tested re-squeezed Ojo Alamo perfs to 600 psi for 15 min - OK. Found csg leak 1734'-95' & SQ w/33 sx cmt. Tested SQ'ed csg leak, which took 0.5 BPM @ 600 psi. Swab tested squeezed csg leak 1734'-95' & found no significant fluid entry. Found csg leak or leaks @ 400'-1000'. Decided to P&A well. Landed 2-3/8" 4.7# J-55 tbg @ 3802' w/AS-1 pkr @ 3680'. Released rig on 2/24/07. Will prepare P&A paperwork.
