

Cmt'd 1st stage w/175 sx Prem Lite cmt w/0.2% CD-32, 1/4 pps Celloflakes, 0.4% FL-52, 2 pps Phenoseal & 2% KCl (12.5 ppg & 2.01 cuft/sx) f/b 175 sx Type III cmt w/0.3% CD-32, 1/4 pps Celloflakes, 0.2% FL-52 & 2 pps Phenoseal (14.2 ppg & 1.48 cuft/sx). Circ 3 bbls cmt to surf.

Cmt'd 2nd stage w/430 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2 pps Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 60 bbls cmt to surf. Released rig @ 12:00 a.m. on 3/12/07.

Production casing will be tested upon completion.

Note: The yield for the cement on the surface casing was previously reported incorrectly as (18.2 ppg & 1.28 cuft/sx). The correct density should be (15.2 ppg & 1.28 cuft/sx).
