McElvain Oil and Gas Properties, Inc. has not completed this well due to lack of a pipeline connection. The potential damage from completion fluids setting on the formation for long periods of time dictates that McElvain typically does not complete new wells until a pipeline connection is available.


The well was drilled and casing cemented as described in previous sundries.

This well should tie into the Williams gathering system. Due to negotiations with the Jicillira Tribe over pipeline ROW's, Williams has informed us that they will allow connection to their system at our risk and expense. The terms and conditions of any transportation thru the pipeline are not clear to any of the parties. As a result of this situations McElvai has contacted another pipeline company in the area for possible connection. As of this time no firm response has been given.

McElvain is hopeful this issue will be resolved in the near future but does not have a firm date given the lack of response the pipeline companies.

McElvain requests that the well be allowed to be in a shut in status until this issue is resolved. We are hopeful to have thi completed and on line in 2007.
