XTO Energy Inc. requests approval for an exception to NMOC Rule 303-C to permit DHC of production from the Pictured Cliffs & Fruitland Coal in the Valencia Canyon Unit #14. XTO Energy, Inc. proposed to downhole commingling these pools upon completion of this well.

Allocations are based on production and are calculated as follows:

PC	Gas: 87%	Oil: 100%	Water: 100%
FC	Gas: 13%	Oil: 0%	Water: 0%

Both pools are included in the NMOC pre-approved pool combinations for downhole commingling in the San Juan Basin. Interest in both pools was common; therefore, notification to owners was not necessary. The NMOC has been notified of our intent by submission of a C-103. Downhole commingling will offer an economical method of production while protecting against reservoir damage, waste of reserves & violation of correlative rights.
