Circ 20 bbls cmt to surf. Cmt'd 2nd stage w/460 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2 pps Phenoseal (11.9 ppg & 2.60 cuft/sx) f/b 175 sx Type III neat cmt (14.5 ppg & 1.39 cuft/sx). Circ 70 bbls cmt to surf.
