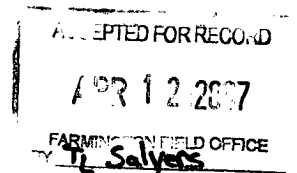
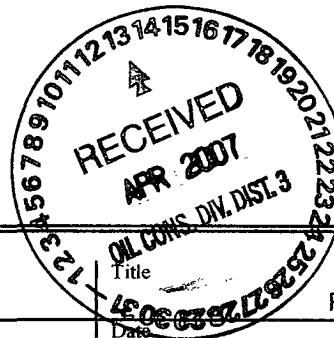

Drill 7-7/8" hole to 4202'. Ran 5-1/2" 17# J-55 csg & set @ 4201'. Cmt w/700 sks (1029 cf) 50/50 Type V POZ cmt w/1% gel, 5# gilsonite, 0.1% CFR-3, 0.4% Halad 9, & 1/8# polyflake. Circ. 5 bbls cmt to surface. Pressure tested 5-1/2" csg to 800 psi-OK.
