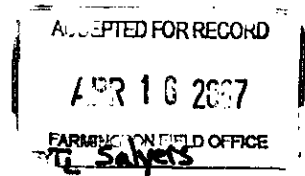

Drilled 7-7/8" hole to 1660' KB (TD) on 4/3/07. Set 5-1/2", 15.5#, J-55, LT&C csg @ 1642' KB on 4/3/07. Cmt w/120 sx Prem Lite cmt w/2% CaCl2, 1/4 pps Celloflakes, 0.2% Cement Dispersant, 0.5% FL-52 & 2 pps Phenoseal (12.5 ppg & 2 cuft/sx) f/b 110 sx Type III cmt w/2% CaCl2, 1/4 pps Celloflakes, 0.2% Cement Dispersant & 0.2% FL-52 (14.2 ppg & 1.49 cuft/sx). Circ 11 bbls cmt to surf. Completed cement & released rig on 4/4/07.

Production casing will be tested upon completion. ✓
