Cement with 200 sks Type V, 2% CaCl2, 1/8#/sk floccle (236 cu.ft.). Circulate 15 bbls cement to surface. Plug down @ 6:30 pm on 04/07/07. WOC. RD Halliburton. Surface casing test will be conducted prior to drilling out from under the surface. BLM will be notified to witness test.
