On 4/14/07, ran 39 joints of new 5-1/2", 15.5#/ft, J-55 LTC casing, set at 1563' KB (7-7/8" hole). (Top of 7-7/8" hole 145', bottom of 7-7/8" hole TD 1573'. Reached TD on 4/13/07.) Pump 10 BBIs gel spacer followed by (53 BBIs lead cement) 140 sacks Premium Lite cement with 3% CaCl<sub>2</sub>, .25 lbs/sk Cello Flake, 5 lbs/sk LCM-1, 8% Bentonite, 0.4% Sodium Metasilicate, 0.4% FL-52A and 112.3% fresh water (yield 2.13 cf/sk; density = 12.1 ppg). Tail cement is (24 BBIs) 100 sacks Type III cement with 2% CaCl<sub>2</sub>, 0.2% FL-52A, 0.2% CD-32 and 59.1% fresh water (yield 1.39 cf/sk; density = 14.6 ppg). Circulated 16 BBIs of good cement to reserve pit. Bumped plug 760 psi, float held.

Pressure test on casing 1620 psi.
