1/6/05 Set 5-1/2" CIBP at 1796'. Tagged plug at 1796'. Circulated hole with mud laden fluid. Spotted 30 sx Class "C" Neat cement on top of CIBP from 1796' to 1500'. PUH to 1065'. Spotted 30 sx Class "C" Neat cement from 1065'-886'. Perforated 7" casing at 357'.

1/7/05 Attempted to break circulation, could not. Mixed and pumped 110 sx Class "C" with 2% Calcium. WOC. Tagged plug at 255'. Pumped 50 sx cement. Perforated 7" casing at 255'. Could not get circulation. Squeezed 50 sx Class "C" Neat cement. WOC.

1/10/05 Tagged plug at 165'. Squeezed 30 sx Class "C" Neat cement. Displaced to 110'. WOC 1 hr.

1/11/05 Tagged plug at 127'. Perforated 7" and 8-5/8" casing at 60'. WOC and tag. Circulated 150 sx Class "C" Neat cement down 7" casing and up to surface of 8-5/8" casing and behind 8-5/8" casing in 20" conductor. WOC 4 hrs. Tagged cement at 60' - still soft. WOC 4 hrs and tagged at 60'.

1/12/05 Tagged cement in 7" casing at 55'. Tagged cement in 20" conductor pipe at 52'. Filled 7" casing up with 20 sx Class "C" Neat cement. Filled 20" conductor pipe up to surface with 100 sx Class "C" Neat cement. Cement stayed at surface. **WELL IS PLUGGED AND ABANDONED. FINAL REPORT.**
