Dear Mr. Levine,

As per our conversation on May 4, 2007, The New Mexico Oil Conservation Division Rule 704 [19.15.9.704 NMAC] requires PNM Gas Resources to perform a mechanical integrity test on the above referenced wells once every five years. Our records indicate that the last test performed on the wells was in May of 1998. Therefore the Aztec District Office of the Oil Conservation Division requires that the above referenced wells be tested or properly plugged and abandoned by no later than September 1, 2007.

The mechanical integrity of the casing-tubing annulus is to be tested by submitting the casing tubing annulus to a pressure of 500 psi for 30 minutes with no more than ten percent gain or loss of pressure.

This pressure is recorded on a chart recorder with a maximum 1000lb spring and a maximum 2 hour clock.

Please provide us a minimum 48 hour notice so that we may be present to witness testing or plugging operations. PNM Gas Resources will provide the equipment and the personnel to complete the testing or plugging operations.
