Ran centralizers on the bottom 3 joints including shoe joint, then every 400'. Cemented with 225 sks 50/50 ClassG:Poz, 4% Gel, .25#//sk D29 Cello Flake, 5#//sk Gilsonite, 2.5#//sk Phenoseal, 13.0# cement, yield 1.43. Plug down, test to 1000 psi, held O.K..

CBL test will be run at a later date.
