Cement with 125 sks Type V, 2% CaCl2, 1/4#/sk flocele (148 cu.ft.). Did not circulate. Plug down @ 7:30 am on 04/29/07. Top out with 80 sks Type V cement. Cement @ surface. Pump 95 sks Type V down casing (206 cu.ft.). Displace with 10 bbls water. Locked up, pressured up to 240 psi. RD Halliburton. RDMD. Surface casing test will be conducted prior to drilling from out under the surface. BLM will be notified to witness test.
