Pressure test casing to 3000 psi, held. Run GR-CCL-CNL from PBTD (1770') to surface. Perforate Fruitland Coal from 1646'-1659' w/4 spf (total 48 holes). Acidize w/250 gals 15% HCL. Frac w/51,000# 20/40 Brady sand & 13,000# resin coated sand in 33,400 gallons of AmBor Max 10/20. Land 2-3/8" tbg @ 1685'.
