Circ 35 bbls cmt to surf. Cmt'd 2nd stage w/675 sx Type III cmt w/8% Bentonite, 1/4 pps Celloflakes & 2% Phenoseal (11.9 ppg & 2.6 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.39 cuft/sx). Circ 59 bbls cmt to surf. Completed cmt job on 5/9/07. Released drilling rig on 5/9/07.
