Set 8-5/8", 24#, J-55, ST&C casing @ 239' on 4/28/07 & cmt'd w/150 sx Type III cmt w/3% CaCl2 & 1/4 pps Celloflakes (14.5 ppg & 1.42 cuft/sx). Circ 12 bbls cmt to surf. Completed cmt job on 4/28/07. PT surf casing to 1500# for 30 min. Tested OK.

Drilling ahead. . .

Drilled 7-7/8" hole to 1790' (TD) on 4/30/07. Set 5-1/2", 15.5#, J-55, LT&C casing @ 1760' on 4/30/07 & cmt'd w/135 sx Prem Lite cmt w/2% CaCl2, 0.2% CD-32, 0.9% FL-52 & 2 pps Phenoseal (12.5 ppg & 2.01 cuft/sx) f/b 100 sx Type III cmt w/2% CaCl2, 0.2% CD-32 & 0.9% FL-52 (14.2 ppg & 1.49 cuft/sx). Did not circ cmt to surf. TOC estimated @ 300'

Production casing will be tested upon completion.
