On 3/5/07 the above well was perforated in the Dakota zone from 7,769' to 7,895' with 3-4 SPF, 0.34" EHD, 120 degree phasing, for a total of 26 holes. On the same date the well was fracture treated with 66,660 gal Delta 210 with 55,000# 20/40 Ottawa sand. The average rate was 24.7 bpm, average pressure 3129 psi, and the final frac gradient was 0.75 psi/ft.

On 3/9/07 the above well was perforated in the Pictured Cliffs zone from 3,430' to 3,363' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 24 holes. On the same date the well was fracture treated with 116,853 gal Delta 140 with 200,200# 20/40 Brady sand. The average rate was 24.8 bpm, average pressure 1840 psi, and the final frac gradient was 0.75 psi/ft
