Drill 7-7/8" hole to 3951'. On 5/30/07, ran 7" 23# P-110 csg & set @ 3951'. Cmt w/385 sks (399 cf) 65/35 POZ cmt w/2% gel, 5# gilsonite, 2% CaCl2, 0.4% Halad 9, 1/8# polyflake. Cmt locked up near end of flush. Circ. 3/4 bbls watery cmt. Pressure tested 5-1/2" csg to 1000 psi -OK. ✓
