Drill to TD @ 1460' on 5/17/07. Run 5½" 15.5# J-55 csg in 7" hole. Land @ 1448', float collar @ 1408'. Cement w/80 sx Type 5 cement w/2% Lodense, 2# PhenoSeal & 1/4# celloflake/sx. Tail w/50 sx Type 5 cement w/2# PhenoSeal & 1/4# celloflake/sx (231 cu ft total slurry). Circulate 6 bbls cement. Pressure test will be reported on completion sundry.
