XTO proposes to reapiir failure by spotting psi 300 chemicals across leak from 3602' - 3868' & pressure psi 300 into leaks. Verbal approval has been granted by Jim Lovato (2:20 p.m.) & Charlie Perrin (2:30 p.m.) on 6/15/07.
