9/5/03 Install and test BOP to 600 psi; test good. Test surface casing to 600 psi; test good. Drill 6 1/4" hole to 450'. SDFN
9/6/03 Drill 6 1/4" hole to 1000'. SDFN.
9/8/03 Drill 6 1/4" hole to 1580'. Rig needs repair.
9/9/03 Rig Repair.
9/10/03 Drill 6 1/4" hole to TD. Tally and run 38 joints 4.5" J-55 10.5# casing; set guide shoe at 1618'. Float at 1578'. Cemented with 114 sx (235 cuft) Class 'B' with 2% metasilicate, 1/4# celloflake and 85 sx (100 cuft) Class 'B' with 2 % CaCl. Bumped plug to 800#, float held. Circ. 6 bbl cmt to surface.
