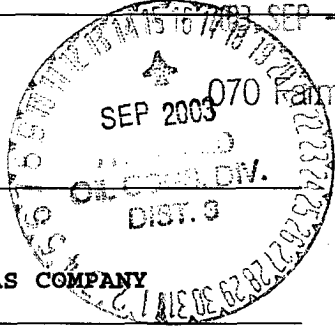

TIH W/5 stands, tag PBDT @ 2267', circ w/air, unload acid water, circ @ PBDT. Pull & L/D tbg, land on hgr w/ end of tbg @ 2189'. ND BOP's, NU WH. Pump off expendable ck. Shut well in. RD. Rig Released.

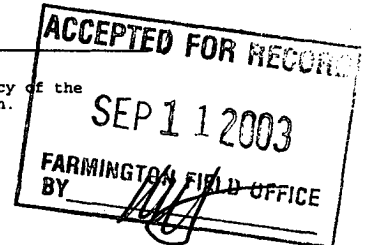
