08/14/03 TIH with 6-1/4" mill, tag @ 3578'. Mill on casing from 3591' returning metal cuttings and cement. TOH. TIH with new mill. Mill casing 3591' to 3611'. Appears to have milled outside casing. TOH.

08/15/03 Decided to sidetrack well. RIH with 7" CIBP, set @ 3523'. Top of bad casing @ 3578'. TIH with 3 degree whipstock and starting mill. Mill window from 3513' to 3515' with air mist. TOH. TIH with 6-1/4" mill and string mills. Open window from 3515' to 3521'. Circulate hole clean. TOH.

08/16/03 TIH with bit and drill new hole from 3521' to 3804'. Dropped into old hole @ 3804. Clean out fill to original TD of 3850' Jet well with air mist.

08/17/03 TD:3850' PBTD:3850' Ran 8 jts. 5-1/2" 15.5# J-55 ST&C casing, set @ 3849'. TOL:3485'. No cement. Released rig 6:00 am on 08/18/03.
