Plug and Abandon Report

SFPRR No. 6Y

2050' FNL & 2000' FEL, Section 29, T16N, R6W

McKinley County, NM

8/12/2002: Rig up JC Well Service. Pick up and trip in with 2 3/8" tubing. Tag PBD at 748'. Roll hole with water. Mix and spot 21 sack bottom plug at 746'. Trip out tubing.

8/13/2002: Trip in and tag plug at 507'. Casing held pressure. Perforate squeeze holes at 100'. Mix and pump 35 sacks cement. Circulated cement to surface. Rigged down. Henry Villanueva with OCD on location throughout job and approved cement volumes. Class B cement was used.

Installed abandonment marker and backfilled pit. Cleaned up location.
