Plug and Abandon Report

SFPRR No. 39

330' FNL & 660' FWL, Section 28, T16N, R6W

McKinley County, NM

8/22-28/2002: Rig up JC Well Service. Trip in with 2 3/8" tubing. Tag PBD at 765'. Roll hole with water. Mix and spot 22 sack bottom plug at 764'. Trip out tubing and WOC. Trip in and tag plug at 503'. Casing failed pressure test. Ran 9 joints tubing (279') spot 16 sacks cement. Trip out tubing and WOC. Trip in and tag cement at 462'. Pressure test of casing failed. Ran 9 joints tubing (279') spot 33 sacks cement. Trip out tubing and WOC. Trip in and tag cement at 274'. Pressure test of casing failed. Ran 9 joints tubing (279') spot 16 sacks cement. Trip out tubing and WOC. Trip in and tag cement at 109'. Pressure test of casing failed. Ran 3 joints tubing (93') and spot 16 sacks cement. Trip out and WOC. Trip in and tag cement at 41'. Casing held 200 PSI. Trip in 1 joint (31') tubing. Mix and pump 35 sacks cement to surface. Trip out tubing. Rigged down. Henry Villanueva with OCD was on location throughout job and approved cement volumes. Class B cement was used.

Installed abandonment marker and backfilled pit. Cleaned up location.
