This well failed a recent bradenhead test. Therefore, we propose to TOH w/pump, rods, & tbq. Set a RBP @ ~3200'. Using pkr, locate csg leak in 7" csg. Squeeze csg leak with 40% excess cmt to circ out bradenhead. Drill out cmt & pressure test to 200 psi. Retrieve RBP & resume production.
