

Set 8-5/8", 24#, J-55 casing @ 374' on 6/24/07 & cmted w/275 sx Type III cement w/3% CaCl2 & 2 pps Phenoseal (14.5 ppg & 1.43 cuft/sx). Circ 28 bbls cement to surf. Pressure tested casing to 1000 psig for 30 min. Tstd OK. Cement job completed on 6/24/07.
