* Change the 8.75" wellbore to: 12.25" for the surface hole.

* Change the surface cement from 50 sks Std (Class B), 2% CaCl₂, 1/4#/sk flocele, (15.6 ppg, 1.18 ft³/sk, 59 ft³ of slurry, 100% excess to circulate to surface) to: 59 sks Std (Class B), 2% CaCl₂, 1/4#/sk flocele (15.6 ppg, 1.18 ft³/sk, 69 ft³ of slurry, 100% excess to circulate to surface).

* Change the 7", 23#, J-55, LT&C casing to: 8.625", 24#, J-55, ST&C

* Change the 6.25" wellbore to 7.875" for the production hole.

* Change the 4.50", 11.6#, J-55, LT&C production casing to: 5.50", 15.5#, J-55, LT&C.
