SG Interests I, Ltd proposes to Temporarily Abandon the W. Bisti 26-13-17 #1 following all guidelines and rules of the BLM & NMOCD. The tubing and rods will be pulled. A CIBP will be set above the current Fruitland completion (1443'-1464'). CIBP to be set @ ±1420' w/40 sx cem. An MIT will be performed per BLM & NMOCD guidelines. In the event the MIT fails, SGI proposes to P&A the W. Bisti 26-13-17 #1 per BLM & NMOCD guidelines. Leak area will be determined, & cem will be spotted 50' below leak to surface, or 250' to surface, whichever is more. Csg will be cut off 4' below surface & P&A marker will be installed per BLM & NMOCD guidelines.
