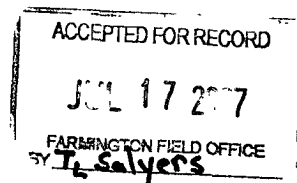



XTO Energy Inc. spudded 12-1/4" surf hole on 5/16/07 & drilled to 245' (surf TD). Set 8-5/8", 24#, J-55, ST&C casing @ 239' & cemented w/214 sx Type III cement w/3% CaCl2 & 2 pps Phenoseal (14.5 ppg & 1.43 cuft/sx). Circ 18 bbls cement to surface. Pressure tested 8-5/8" casing to 700 psi for 30 min. Tested OK. Completed cement job on 5/16/07.
