Deepening started 06/13/2007. Completed 06/22/2007. Drilled 90' into the Pictured Cliff formation to allow for a sump from which to pump water, new TD is 3047'. We used a mudlogger during drilling to monitor the Pictured Cliff for signs of gas, there were none.

7" casing is unchanged, and set @ 2717'. Set new pre-drilled 5 1/2" 15.50# liner, top of liner @ 2665', bottom of liner landed @ 3043'. Perforations are 2711'- 2957' w/ 15/16" holes 4 SPF total of 246 ft and 984 holes.

2 3/8" tubing run and landed @ 3008'. 3/4" rod string run. Well returned to production 6/22/07.
