Drill 7-7/8" hole from 100' (inside 8-5/8" surface csg) to 4286'. On 7/5/07, ran 5-1/2: 17# J-55 & N-80 csg & set @ 4286'. Cmt w/375 sks (735 cf) 65/35 "V" POZ cmt w/6% gel, 10# gilsonite, 1/4# polyflake. Tailed w/250 sx (365 cf) 50/50 "V" POZ cmt 3% gel, 5# gilsonite, 1/8# polyflake, 0.2% CFR-3, 0.2% Super CBL, & 0.5% Halad-9. Did not circ. cmt. Pressure tested 5-1/2" csg to 1000 psi for 30 min. -OK.
