XTO Enhergy Inc. proposes to downhole commingle production from the Basin Dakota (71599) and the Gallegos Gallup (26980) upon completion of drilling. Allocations are based upon the average monthly production of commingled Dakota/Gallup wells in the T26N-R11W area:

Basin Dakota:	Gas: 36%	Oil: 5%	Water: 30%
Gallegos Gallup:	Gas: 64%	Oil: 95%	Water: 70%

Both pools are in the NMOCD pre-approved pool combinations for downhole commingle in the San Juan Basin. Ownership is diverse between pools, therefore owners were notified via certified, return receipt mail on July 31, 2007. Downhole commingling will offer economical production while protecting against reservoir damage, waste of reserves & violation of correlative rights. NMOCD was notified of our intent to DHC via submission of form C103 on July 31, 2007.
