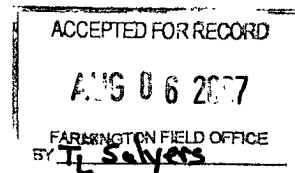

Cemented lead w/225 sx (58 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1.4% Halad 9, 1/10% CFR3, 5#/sx Gilsonite & 1/4# Floce. No cement to surface, top of cement is at 2,700' which was determined using a CBL. Tested casing to 1500 psi.
