On 7/12/07 the above well was perforated in the Dakota zone from 8,483' to 8,631' with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 25 holes. On 7/13/07 the well was fracture treated with 56,091 gal Delta 200 with 43,640# 20/40 Ottawa sand. The average rate was 20.2 bpm, average pressure 3973 psi, and the final frac gradient was 0.69 psi/ft.
