PNM proposes to P&A the referenced well as follows:

RCVD AUG 21 '07
OIL CONS. DIV.
DIST. 3

MOL. RU. PU on tubing and release packer in tension at 2244'. TOH with tubing and packer.

Plug #1 (Aqua Zarco perforations and top, 2220' - 2120'): TIH and set CR at 2220'. Pressure test tubing. Pressure test casing to 800#. Spot total 16 sxs Type III cement inside casing above CR to isolate the Aqua Zarco perforations and top. PUH to 536'.

Plug #2 (8.625" casing shoe and Chinle, Entrada tops, 536' - Surface): Spot approximately 60 sxs cement from 536' to surface, circulate good cement out casing valve. TOH and LD tubing. Shut in well and WOC.

ND BOP and cut off wellhead. Install P&A marker. RD, MOL and cut off anchors.
