

XTO Energy Inc. spudded 14-3/4" surface hole & drilled to 400' (surf TD) on 8/1/07. Set 11-3/4", 42#, ST&C casing @ 389' on 8/2/07 & cemented w/300 sx Type V cement w/2% CaCl2 & 1/8 pps Poly-E-Flake (15.4 ppg & 1.19 cuft/sx). Circ 12 bbls cement to surf. Finished cement job on 8/2/07. Pressure tested surf casing to 1300 psig for 30 min. Tested OK.

Drilled 10-5/8" intermediate hole to 1735' (Int TD) on 8/6/07. Set 8-5/8", 24#, ST&C, J-55 casing @ 1586' & stage tool @ 1073' on 8/7/07. Cemented 1st stage w/65 sx Prem Lite cement w/2% CaCl2, 0.5% CD-32, 5 pps CSE, 0.5% FL-52, 5 3/4 pps LCM-1, 70.5% LW-6 & 0.2% Na Metasilicate (9.7 ppg & 3.23 cuft/sx). Circ 12 bbls cement to surface. Cemented 2nd stage w/110 sx Prem Lite cement w/0.5% CD-32, 5 pps CSE, 0.5% FL-52, 5 3/5 pps LCM-1, 70.5% LW-6 & 0.2% Na Metasilicate (9.7 ppg & 3.23 cuft/sx). Circ 10 bbls cement to surface. Finished cement job on 8/7/07. Pressure tested intermediate casing to 1500 psig for 30 min.
