Set 9-5/8", 36#, J-55 casing @ 824' on 7/16/07 & cemented with 275 sx Prem Lite cement w/1% CaCl2, 0.2% CD-32 & 0.2% FL-52A (12.3 ppg & 2.09 cuft/sx) f/b 100 sx Type III neat cement (14.5 ppg & 1.39 cuft/sx). Circulated 64 bbls cement to surf. Pressure tested casing to 1000 psi for 30 min. Tested OK.
