On 7/18/07 a CIBP was set at 6,320' and shoot squeeze holes @ 6,280' and 5,770' with 4 SPF, 0.34" EHD, 120 degree phasing. A cement retainer was set @ 6,007' and on 7/19/07 the 4 1/2" casing was cemented with 80 sx (21 bbls) of 50/50 POZ w/2% Gel, .10% CFR 3, 3% Halad-9. On 7/21/07 set a 4 1/2" packer @ 5,785', cemented with 150 sx (39 bbls) 50/50 POZ w/2% Gel, .1% CFR-3, 3% Halad-9 Tested casing to 1000 psi, ok. On 7/23/07 milled out CIBP @ 6,320' set a frac plug @ 6,550' @ 6,570' when testing plug at 2950 pis squeeze holes gave way, POOH with frac plug.
