On 7/24/07 set a CIBP @ 6,550' then the above well was perforated in the Point Lookout zone from (6,519' to 6,248') with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 30 holes. On 7/28/07 the well was fracture treated with 54,920 gal Delta 140 with 98,525# 20/40 Brady sand. The average rate was 21.8 bpm, average pressure 3764 psi, and the final frac gradient was 0.56 psi/ft.

On 7/30/07 set a frac plug @ 6,170' then the above well was perforated in the Cliffhouse zone from (5,951' to 6,148') with 4 SPF, 0.34" EHD, 120 degree phasing, for a total of 30 holes. On the same date the well was fracture treated with 102,968 gal Slickwater with 96,010# 20/40 Brady sand. The average rate was 48.9 bpm, average pressure 2400 psi, and the final frac gradient was 1.13 psi/ft.
