Drilled 12 1/4" hole to 290' on 8/9/07, set 6 jts of 9 5/8", H-40, ST&C, 32.3# casing at 287'. Cemented w/200 sx (42 bbls) "G" neat cement w/2% CaCl and 1/4#-sx Floseal. Circulated 15 bbls of cement to surface. Test casing to 750 psi, held ok.
