XTO Energy Inc. spudded 17-1/2" conductor hole on 9/7/07 & drilled to 92'. Set 8-5/8", 24#, J-55 conductor casing @ 90' & cemented w/ 116 sx Type III cement (15 ppg & 1.39 cuft/sx). Circ 16 bbls cement to surf. Drilled 12-1/4" surf hole to 870' (surf TD) on 9/11/07. Set 9-5/8", 36#, J-55 casing @ 868' & cemented w/275 sx Prem Lite cement (12.3 ppg & 2.09 cuft/sx). Circ 60 bbls cement to surf. Finished cement job on 9/11/07. Pressure tested 9-5/8" casing to 1000 psig for 30 min. Tested OK.
