Drilled 12-1/4" hole to 343'. On 6/22/03 set 8 jts 9-5/8" 36# J-55 casing at 334'. Cemented with 175 sx (38 bbls) Class "B" cement w/ 2% CaCl and 1/4# Flocele. Circulated 10 bbls cement to pit. Pressure tested casing to 1500 psi.

Drilled 8-3/4" hole to 3399'. On 6/26/03, set 79 jts 7" 23# J-55 casing at 3373'. Cemented with: Lead- 600 sx (158 bb 50/50 Poz w/ 3% gel, 5# Gilsonite, 1/4# Flocele, 0.1% CFR-3, and 0.4% Halad 344. Tailed in with 50 sx (10 bbls) Class "B" w/ 0.4% Halad 344. Circulated 58 bbls cement to pit. Pressure tested casing to 1500 psi and 300 psi- OK.

Drilled 6-1/4" hole to 3703' then underreamed hole to 9-1/2" to 3703'. Cavitated openhole with natural and air assiste surges to remove wellbore material. Landed 2-3/8" 4.7# J-55 tubing in openhole at 3688'.

Currently waiting for pipeline connection to turn well to sales.
