A rig-less squeeze will be performed with squeeze holes shot @ approximately 5110' and 300 sx of Premium Lite FM Cement pumped. 2nd squeeze will be performed after the rig moves on location. Back pressure is to be monitored per BLM.

Jim Lovato gave permission to defer remedial cementing until Dakota completion. Verbal permission to proceed.
