Cemented lead w/675 sx (187 bbls) 50/50 POZ "B" cement w/3% Gel, 5# Gilsomite, 1/4# Floccle, 0.1% CFR 3, 0.4% Halad 344 and tail w/75 sx (19 bbls) STD "B" cement w/0.4% Halad 344. Circulated 25 bbls of cement to surface. Tested casing to 1,500 psi.
